

Terms of Service

Effective date: April 7, 2026

These Terms of Service (“Terms”) govern your use of GetMeA (www.getmea.org), the GetMeA mobile application (iOS and Android), and all related services (collectively, the “Service”), operated by Music App LLC . By creating an account or using the Service, you agree to these Terms. If you do not agree, do not use the Service.

1. Eligibility

The only requirements to be included in the list include: your general location, what instrument(s) you play, you must be over 18 years of age or more, and you must be willing to receive communication notifying you of opportunities to play. If you are on the list, you agree that you can play a gig on a professional level. By using the Service, you represent that you meet the requirements.

2. Accounts

Registration

You may register using an email address and password, or via a supported OAuth provider (Google, Apple, or Facebook). You are responsible for maintaining the confidentiality of your credentials and for all activity that occurs under your account.

Profile Completion

A complete profile (first name, last name, email, phone number, city, state, and zip code) is required before browsing other musicians. You agree to provide accurate and current information and to keep it updated.

Account Security

Active device sessions can be viewed and revoked at any time from within the app. You are responsible for any activity performed on sessions you have not revoked. Notify GetMeA immediately via the [support page](#) if you suspect unauthorized access.

Account Termination by You

You may delete your account at any time from within the app. Deletion removes your profile from the directory immediately. Certain data may be retained as described in the [Privacy Policy](#).

3. The Service

GetMeA is a musician discovery platform. It allows musicians to create profiles and be discovered by other musicians searching by instrument, genre, location, ability, or name. GetMeA does not facilitate transactions, bookings, or agreements between users. Any arrangements made between users are solely between those users.

4. Subscriptions and Billing

Free Tier

A free account allows you to create a profile and search the directory. Contact information (email address, phone number, and location) is visible on all completed profiles. Profile photo, title, bio, website URL, payment handles, and YouTube links are not displayed in a free profile.

Paid Subscription

A monthly subscription unlocks a full profile visible to other users, including profile photo, title, bio, website URL, payment handles, and YouTube links. Subscription pricing is displayed at the time of purchase.

Billing

Payments are processed by [Stripe](#). By subscribing, you authorize recurring charges at the then-current rate until you cancel. Your payment card details are entered directly with Stripe and are not stored by GetMeA.

Cancellation

You may cancel your subscription at any time through the billing portal accessible from within the app. Cancellation takes effect at the end of the current billing period. No partial-period refunds are issued unless required by applicable law.

Refunds

All sales are final except where required by applicable consumer protection law. Refund requests may be submitted via the [support page](#) and will be evaluated on a case-by-case basis.

5. User Content

Your Content

You retain ownership of the content you submit to GetMeA, including profile text, photos, and YouTube links (“User Content”). By submitting User Content, you grant GetMeA a non-exclusive, worldwide, royalty-free license to store, process, display, and transmit that content as necessary to operate the Service.

Accuracy

You are solely responsible for the accuracy of your User Content. You must not submit false, misleading, or impersonating information.

Profile Photos

Uploaded photos must depict you or content you have the right to use. Photos that are obscene, offensive, or infringe third-party rights are prohibited and may be removed without notice.

YouTube Links

You may add links to YouTube videos which you own or have the right to share. GetMeA fetches video titles from YouTube's public API at the time of submission. You are responsible for ensuring linked content complies with YouTube's Terms of Service.

Content Removal

GetMeA reserves the right to remove any User Content that violates these Terms or is otherwise deemed inappropriate, without prior notice.

6. Acceptable Use

You agree not to:

- Use the Service for any unlawful purpose or in violation of any applicable law
- Harass, threaten, or harm other users
- Create false, duplicate, or impersonating accounts
- Scrape, crawl, or systematically extract data from the Service without written permission
- Attempt to gain unauthorized access to any account, system, or network associated with the Service
- Interfere with or disrupt the integrity or performance of the Service
- Use the Service to transmit spam, malware, or other harmful content
- Circumvent any technical measures used to restrict access

7. Payment Handles

Subscribers may display Venmo, Cash App, and PayPal handles on their profiles. GetMeA is not a party to any payment or transaction conducted through these third-party platforms. GetMeA makes no representation regarding the availability, accuracy, or security of those platforms. Any disputes arising from payments made through those platforms are solely between the parties involved.

8. Third-Party Services

The Service integrates with third-party services including Stripe, Google, Apple, Facebook, Cloudflare, and YouTube. Use of those services is subject to their respective terms of service and privacy policies. GetMeA is not responsible for the practices or content of any third-party service.

9. Privacy

Use of the Service is also governed by the [Privacy Policy](#), which is incorporated into these Terms by reference.

10. Intellectual Property

All rights in the Service, including the software, design, trademarks, and original content, are owned by Grafing Productions or its licensors. Nothing in these Terms grants you any right to use GetMeA's trademarks, logos, or proprietary content outside of your normal use of the Service.

THE SERVICE IS PROVIDED "AS IS" AND "AS AVAILABLE" WITHOUT WARRANTIES OF ANY KIND, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, AND NON-INFRINGEMENT. GETMEA DOES NOT WARRANT THAT THE SERVICE WILL BE UNINTERRUPTED, ERROR-FREE, OR FREE OF VIRUSES OR OTHER HARMFUL COMPONENTS.

GETMEA MAKES NO REPRESENTATIONS REGARDING THE ACCURACY OR COMPLETENESS OF USER PROFILES OR THE SUITABILITY OF ANY USER FOR ANY PURPOSE.

12. Limitation of Liability

TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, MUSIC APP LLC AND ITS OFFICERS, DIRECTORS, EMPLOYEES, AND AGENTS SHALL NOT BE LIABLE FOR ANY INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL, OR PUNITIVE DAMAGES, INCLUDING LOSS OF PROFITS, DATA, OR GOODWILL, ARISING OUT OF OR IN CONNECTION WITH YOUR USE OF THE SERVICE, EVEN IF ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

IN NO EVENT SHALL MUSIC APP LLC TOTAL LIABILITY TO YOU EXCEED THE GREATER OF (A) THE AMOUNT YOU PAID TO GETMEA IN THE TWELVE MONTHS PRECEDING THE CLAIM OR (B) ONE HUNDRED US DOLLARS (USD \$100).

13. Indemnification

You agree to indemnify and hold harmless Music App LLC and its officers, directors, employees, and agents from any claims, damages, losses, liabilities, and expenses (including reasonable legal fees) arising from your use of the Service, your User Content, or your violation of these Terms.

14. Termination

GetMeA may suspend or terminate your account at any time, with or without notice, for conduct that violates these Terms or is otherwise harmful to other users, GetMeA, or third parties. Upon termination, your right to use the Service ceases immediately. Provisions that by their nature should survive termination (including Sections 10, 11, 12, 13, and 15) will do so.

15. Governing Law and Disputes

These Terms are governed by the laws of the State of Ohio, without regard to conflict-of-law principles. Any dispute arising under or relating to these Terms shall be subject to the exclusive jurisdiction of the courts located in Toledo, Ohio, USA.

16. Changes to These Terms

GetMeA may update these Terms from time to time. The effective date at the top of this page reflects the most recent revision. For material changes, GetMeA will make reasonable efforts to notify users before the changes take effect (e.g., via in-app notification or email). Continued use of the Service after updated Terms take effect constitutes acceptance of those Terms.
